WHEREAS, on May 20, 1915, W. H. Irvine, of the County and State aforesaid, did file his petition in bankruptcy in the United States District Court for Western District of South Carolina, praying that he be adjudged a bankrupt; and

Pool All that piece, parcel and tract of land, situate, lying and being in Bates Township, in the County of Greenville, and in the State aforesaid, about twelve miles from Greenville Court House, and about three and one-half miles beyond Travlers Rest, and fronting on the Road leading from Belle View to White Horse Road, and adjoining lands of Alfred Edwards, Alex. Mc Kinney, Mrs. Louise Bishop, and others, and containing fifty-six (56) acres more or less. Being the same tract of land conveyed to W. H. Irvine, deceased, by George W. Bishop, by deed, dated September 5th 1910, and recorded in the R. M. Office for Greenville County in Vol. 8, Page 592.
