(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said Joseph Britton, all that certain piece, parcel or lot of

land lying and being situate in Chick Springs Township in the County and State aforesaid on the north side of Anoree River containing one acre, more or less, being one half of a lot sold by Y. F. Hume to me, and bounded by lands of the estate of Alfred Taylor, Deceased, S. H. Foster, Chick Springs Co. and others.

TOGETHER with all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Joseph Britton, his heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

Joseph Britton, his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
