H. J. Lauford,in the State aforesaid,
in consideration of the sum of Four Thousand and No 100 (\$2000.00) DOLLARS,
to me in hand paid at and before the sealing of these presents by G. R. Custer.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

G. R. Custer, all that certain, piece, parcel or lot of land situate, lying, and being in the State and County aforesaid, in the Clayton Springs Township and near the town of Greenville S.C., and having the following lines and boundaries, to wit:

Beginning at an iron pin of the East side of Mosetta road and running thence S. 86.30 E. 1124 feet to a stone 3x; thence N. 1.55 E. 200 feet to a stone 3x Butchings corner; thence N. 86.30 W. 662 feet to a stone; thence N. 7.35 W. 10 feet and 8 inches to a stone 3x; thence N. 86.30 W. 542 feet to an iron in the said Mosetta road; thence with the said road in a southerly direction 210 feet and 8 inches to the beginning corner aforesaid containing five and one-half acres, more or less, and being the same tract of land conveyed to me by J.
