NOW, KNOW ALL MEN BY THESE PRESENTS, That Me J. F. Freeman and D. R. Freeman of Greenville County in the State aforesaid, in consideration of the sum of Three Hundred and fifty six (\$ 356.00 DOLLARS) to us in hand paid at and before the sealing of these presents by H. E. Alewine of the State and County aforesaid.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said H. E. Alewine his heirs and assigns all of that one piece, parcel, and lot of land situated in the State and County aforesaid in the Town of Taylor, S. C. this being a part of the land formerly owned by Robert Gibson and having the following metes and bounds, Beginning at iron pin Batson Corner, thence N 10 1/8 W 408 feet to iron pin on old line, thence S 68 1/4 W 83 feet 3 inches to iron pin, thence S 10 1/8 E 403 feet 6 inches to iron pin on National Highway thence along said Highway N 72 1/4 E 72 feet to the beginning, containing seventy one one hundredths .712 acres more or less,

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said H. E. Alewine, his heirs and assigns, forever.
