NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Robert L. Campbell of Muscular
County in the State aforesaid,
in consideration of the sum of Fourteen Hundred & sixty ¹⁴⁰⁰ DOLLARS,
to me in hand paid at and before the sealing of these presents by Grover M. Thompson of Muscular
County

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
G. M. Thompson, all that certain tract of land, containing
eighty one (81) acres, more or less, situate in Dunklin Town-
ship, State and County aforesaid, on Big Horse Creek, waters of
Reddy River, having the following bearing and distances to wit
Beginning at a new corner in the Public road, thence S.
67 1/4 N. 14.00 to a stake 3/4 new in the field, thence S. 87 1/2
N. 30.89 to a stake 3/4; new on the east bank of the said
creek. Bounded on these two lines by a tract this day
conveyed by the said R. L. Campbell to G. S. Campbell,
thence up the meanderings of the said creek about 20.00
to a stone, 3/4 old on the east side of the said creek
Bounded by W. M. Ridgeway, thence S. 88 1/2 E. 46.93 to a
stone, 3/4 old, on the west side of the road, Bounded by
J. H. Kirby thence along said road, S. 5 1/4 E. 7.00 angle
thence S. 1/2 E. 4.15 to the beginning Bounded by J. H.
Kirby. Divided the 21st day of November 1917 by Mrs.
L. Mitchell, Surveyor and C. E. Being a part of the
Stone tract.
