in the State aforesaid,
in consideration of the sum of Two hundred seventy-five (\$275.00) DOLLARS,
to me in hand paid at and before the sealing of these presents by

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Janie Blessingame, her heirs and assigns, All that lot of land situate in Gantt Township in said County and State, containing Four and 55/100 (4-55/100) acres, more or less and known as Lot No. 5 in the subdivision of the lands of James Scott, deceased: Beginning at an iron pin on the upper line of lot No. 3 at the corner of lots Nos. 4 and 5, and runs thence S. 26-30 E. 6.30; thence N. 23-15 E. 5.36 to a hickory; thence N. 67 W. 8.65; thence S. 2 W. 6.75 to the beginning corner. The above lot of land is the one allotted to James and Arizona Williams in the parol partition and division among the heirs at law of James Scott land said lot of land being sold and deeded by the Master to J. Walter Moon and recorded in R.M.C. Office.
