in consideration of the sum of Four hundred and fifty (\$450.00) DOLLARS,
 to me in hand paid at and before the sealing of these presents by Mollie B. Johnson

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Mollie B. Johnson, her heirs and assigns forever all that certain piece, parcel or lot of land situate, lying and being in Oaklawn Township, Greenville County and State aforesaid, having the following metes and bounds: Beginning at a stone near Holly on Pelzer Road, north side running N. 58 E. 3.20 to iron pin in Middle of McKee Drive-way; thence N. 18-75 W. 16.13 to stake; thence S. 58 W. 3.20 to stake on Pelzer Mfg. Co's line; thence S. 18-75 E. 16.13 to beginning corner, being part of the tract of land conveyed to D.V. Garrison by will and dated July 3rd, 1873 of C.C.
