Now know all men by these presents, That *He H. D. Parrish and T. C. Gower*  
of the City of *Greenville*, in the State aforesaid;  
in consideration of the sum of *Six Hundred Dollars*  
to *us* in hand paid at and before the sealing of these presents by

*L. D. Barr*  
(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

For another Dower to this Deed see Deed Book 27 at page 75.

*L. D. Barr*, All that certain lot or parcel of land situate near  
the City of *Greenville*, County and State aforesaid, known  
as a part of the *Buist* property and described as follows:  
Beginning at a stake on *Buist Avenue* one hundred feet  
from the intersection of *Buist Avenue* and *Rutherford Road*  
corner of lots Nos. 10 and 11, thence along lines of lot Nos. 10  
and 11, one hundred and eighty nine and one-half (189 1/2)  
feet to a stake; thence in an easterly direction one  
hundred feet (100) to corner of lots Nos. 11 and 12; thence  
in a southerly direction along lines of lots Nos. 11 and  
12, one hundred and eighty nine and one-half (189 1/2)  
feet to a stake on *Buist Avenue*; thence along said  
*Buist Avenue* in a westerly direction one hundred (100)  
feet to the point of beginning, and being known as lot  
No. 11, according to plat made by *W. D. News*, June 1st,  
1911, and this being one of the lots deeded to us by  
*T. C. Gower*, by deed dated February 6th, 1918, and  
recorded in the R. M. C. Office for *Greenville County* in

*L. D. Barr, his* heirs and assigns, against *ourselves* and *our* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.

*second* year of the Sovereignty and Independence of the United States of America.

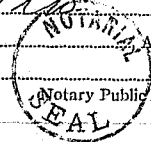

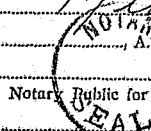
