 to *me* in hand paid at and before the sealing of these presents by *P. J. Stokes*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said *P. J. Stokes*, his heirs and assigns all that tract of land, situate, lying and being in *Highland Township, Guernsey County, South Carolina, near the Jordan Road*. Beginning at a stake and running thence *S. 87 E. 14.00* to a black gum, thence *South 14.00* to a stone on old *Wm. Stokes' line*; thence *S. 77 W. 9.50* to stone, thence *North 15.38* to the beginning corner containing eight acres more or less and being the eight acre tract this day conveyed to me by *J. F. Stokes et al.*

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

*P. J. Stokes, his* heirs and assigns, forever.

AND *I* do hereby bind *myself & my* heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

heirs and assigns, against *me* and *my* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
