Julia Mills (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Julia Mills, all that certain piece, parcel and lot of land, situate, lying and being in the State and County aforesaid, in or near the Town of Kree, and having the following metes and bounds, to-wit: Beginning at Mattie Moores' Corner on New street and running thence with said street 75 feet to Johnson's corner; thence 209 feet to Hawkins' line thence with Hawkins line 157 1/2 feet to Mattie Moores' Corner; thence with Mattie Moores' line 232 feet to the beginning corner. Being the same lot conveyed to me by W. D. Simmons in deed bearing date of Jan. 10th - 1916 and recorded in Vol. 38 page 484.
