County and in the State aforesaid,
in consideration of the sum of Ten Dollars & other considerations DOLLARS,
to me in hand paid at and before the sealing of these presents by John J. Nol of County & State
aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
John J. Nol and his heirs, all that certain lot or parcel
of land situate in Greenville County State of South
Carolina and lying on the north side of Sullivan St.
in the Sixth Ward of the City of Greenville, and has
the following measurements fronting on the north side
of Sullivan St. fifty feet, the Eastern line being one
Hundred & Eighteen & half feet, the Western line
one Hundred & nineteen & eight tenths feet, &
the line same as the front, being the house & lot
in which J. J. Nol now resides & is known as
no. 148.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or, appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said John J. Nol & his heirs and assigns, forever.

AND I do hereby bind myself & my heirs, executors and administrators, to warrant and
forever defend, all and singular, the said premises unto the said John J. Nol & his
heirs and assigns, against me and my heirs, and against
every person whomsoever lawfully claiming or to claim the same, or any part thereof.
