NOW, KNOW ALL MEN BY THESE PRESENTS, That I, M.H. Goodlett

in the State aforesaid,
in consideration of the sum of Two thousand (\$2000.00) DOLLARS,
to me and other valuable consideration
in hand paid at and before the sealing of these presents by

M. McKinnon

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
M. McKinnon, and his heirs : All that certain piece, parcel or tract of land situate,
lying and being in the County of Greenville, State of South Carolina, about one and a half
miles from Greenville Court House, containing Nine and forty-eight hundredths (9.48) acres,
more or less, bounded on the North by Norwood, on the East by Norwood and Dickson, on the
South by Dickson and McDaniel, and on the west by McDaniel and Norwood; this being the
same tract of land conveyed to me by R.W. Miller, L.C. Miller, W.F. Miller, Lucy M. Gerisch,
Robbie L. Miller, and Sallie R. Miller by deed recorded in R.M.C. Office for Greenville
County in Vol. 23, at page 92.
