 in consideration of the sum of Six hundred ninety-two & 25/100 DOLLARS,  
 to me in hand paid at and before the sealing of these presents by

W.E. Stone  
 (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said  
W.E. Stone, All that piece, parcel or lot of land situate, lying and being in Oaklawn Township, County and State aforesaid, containing Ten and sixty-five one one-hundredths (10-65/100) acres, more or less, more fully described as follows, to-wit:-  
Beginning at stone 3xom and running thence N. 49-1/4 E. 11.01 chs. to pin in road 3xnm; thence with road N. 58-1/2 W. 20.29 to pin 3xnm in road; thence S. 26-1/4 E. 19.99 to the beginning corner said land being a part of that tract of land conveyed to me by W.C. Lindley by deed bearing date Dec. 29, 1909 and recorded in office of R.M.C. for said County in Vol. 5, page 344 and lying by lands of J.W. Stone, W.C. Hopkins and others.
