(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said A. Louise Glover, All that certain piece, parcel or lot of land situated, lying and being in Greenville County, South Carolina, just out side of City Limits of Greenville on the Spartanburg Road and being known as Lot No. 1, according to a plat made for W.A. Chandler and J.P. Ballenger, April 1916 by R.E. Dalton, C.E. said plat is recorded in the office of Register of Mesne Conveyance for Greenville County in plat book C., at page 277, and having the following metes and bounds, to wit: Beginning at an iron pin on the Spartanburg Road north side, joint corner with lot No. 5, of the Property of W.A. Bates, and running thence N. 18-14 W. three hundred and eight feet to an iron pin on a line of W.A.
