This agreement made and entered into this the 14, day of February/ April, 1919 by and between

W.T. Henderson, of the one part, and W.P. Garrett, of the other,

Witnesseth:

That the said W.T. Henderson has hereby let and rented to the said W.P. Garrett that certain tract

That the said W.T. Henderson has hereby let and rented to the said W.P. Garrett that certain tract of land containing 65 acres, more or less, situate near Travelers Rest in the County and State aforesaid, and known as the H.P. Coggin's Place, for the year 1919, and for the use and occupation of the same for agricultural purposes, the said Garrett will deliver to the said Henderson at Greenville, South Carolina on or by December 1st, 1919, five (5) bales of good white cotton duly packed and merchantable and weighing 500 pounds each.

It is further agreed that the said Garrett will preserve and keep all terraces on said premises in good condition.

It is further agreed that if the said Garrett gives to the said Henderson at any time during the month of August, 1919 written notice of his intention to buy said premises for the sum of Forty-five hundred dollars, the said Henderson will upon the said Garrett paying him the bales of cotton above stipulated and at the time stated, together with interest on the sum of \$4500.00 at the rate of eight per cent per annum, from January 1st, 1919, then the said Henderson will receive the said five bales of cotton as part purchase money on said land, provided said cotton is worth as much as \$500.00 at that time; and if not worth that much, the said Garrett will make up the difference and pay altogether not less than the sum of \$500.00, then said Henderson will execute and deliver to him his deed and thereby convey to him said land, provided further that the said Garrett will at the same time execute and deliver to the said Henderson his note or notes whereby he obligates to pay to the said Henderson \$500.00 on or by December, each consecutive year thereafter until the remainder of the purchase price has been paid in full.

Said note or notes to draw interest from December 1st, 1919, at the rate of Eight per cent per annum until paid, payable annually, and if not so paid to draw interest at the same rate as the principal until paid, and secure the same by a first mortgage on said premises. If said notice is not given as aforesaid, then this contract shall be exclusively a contract or

lease for the year 1919. Time is of the essence of this contract.

If said purchase and sale is not made as herein provided, then the said Garrett will surrender possession of said premises at the end of the year 1919; that upon his performing all the terms and conditions therein, the said Henderson will do and perform all of the obligations on his part, and to all of the foregoing, each of the parties hereto do bind themselves, their heirs and

assigns, and in duplicate set their hands and seals the day and year first above written,.
