in consideration of the sum of  
*Twenty Dollars and other valuable Considerations* DOLLARS,  
to *me* in hand paid  
at and before the sealing of these presents by *G. F. Hinkle*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

*G. F. Hinkle, all that certain piece, parcel or lot of land situate lying and being on Howe Street, in Ward Six of the City and County of Greenville, State of South Carolina, and having the following metes and bounds, to wit: Beginning at an iron fence post on Howe Street, corner of Furman University property, and running thence with its line N. 68. 31 W. 73. 2 feet to  $\pi$  on Concrete Culvert; thence with Dickson's line N. 69. 16 W. E. 4 feet to iron pipe; thence N. 36. 0 E. 70 feet to  $\pi$  on wall; thence S. 70. 24 E. 135. 1 feet to iron pipe on Howe Street; thence with Howe Street S. 21. 14 W. 70 feet to the beginning corner, and being lot #1 as shown on plat made by R. E. Dalton, Engineer and recorded in Plat Book "C" page 89, R. M. C. office for Greenville County, and being part of the land conveyed to me by Furman University and B. E. Meek, and all of the strip of land conveyed to me by H. J. Dickson, as a part of the consideration herein above expressed, the grantee herein agrees to assume and pay note of grantor to W. F. Walker for Thirty-Five Hundred (\$3500.00) Dollars, dated April 9th 1917, and due April 9th 1919, which is secured by a mortgage of the premises herein conveyed. Said mortgage being recorded in R. M. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *G. F. Hinkle, his*  
heirs and assigns, forever.
