in the State aforesaid,  
 in consideration of the sum of  
*Fifteen Hundred* DOLLARS,  
 to *me* in hand paid  
 at and before the sealing of these presents by *W. R. Forest*.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said  
*W. R. Forest*, all that certain tract of land situate  
 in *Bates Township*, in the County and State  
 aforesaid, on the *White Horse Road*, containing  
 by estimate, One hundred and fifty-two (152) acres,  
 more or less and bounded by lands of  
*John McKinney*, *Kerr Duck*, *Paul Brown* and  
*J. H. McKinney*, being the same tract of land  
 Conveyed to me by *J. T. Poe*, Jr. by Deed recorded  
 in the *W. H. C. Office* for *Greenville*, *S. C.* in  
 Deed Book 28 at page 560 bearing and accepting  
 however, from this Deed forty (40) acres more or  
 less, cut off from the Northern end of said  
 tract and Conveyed to *J. T. McKinney* by Deed  
 recorded in Book 39 page 207, and thirtysix (36)  
 acres cut off from the Northern end of said
