(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Watkins, his heirs and assigns, all of that certain piece, parcel and tract of land situated in the State and County aforesaid, about five miles the City of Greenville, adjoining lands of G.Hawkins, E.E. Watkins and tracts 1 and 3 in the division of the real estate of the late Z.B. Watkins, and shown on a survey and plat made by W.A. Adams, Nov. 26, 1918 and having the following metes and bounds to-wit: Beginning on iron stake, joint corners of tracts 1, 2, 3 and 4; thence S. 29-1/2 E. 22.20 to stone 3xnm; thence S. 89-1/2 W. 23.35 to stone 3xom; thence N. 39-1/2 W. 13.30 to stake; thence N. 65-3/8 E. 22.75 to the beginning, containing thirty-six and three-fourths acres, more or less, this being tract No. 2 on the above named plat.
