KNOW ALL MEN BY THESE PRESENTS, That *Mr. H. D. Parrish and T. C. Gowen* of the City of *Greenville*

in the State aforesaid, in consideration of the sum of *Two Dollars and other valuable considerations* DOLLARS, to *us* in hand paid at and before the sealing of these presents by *Lucy L. Heidman and Lelou Gillespie*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Lucy L. Heidman and Lelou Gillespie their heirs and assigns: All that tract or parcel of land situate in the County of Greenville, in the said State, and has the following metes and bounds, to-wit: Beginning at a stone 3 1/2 in. (in place of a stake) at S. W. Corners corner and running thence N. 59 3/4 E. 28.40 to a stone 3 1/2 in. by a large Hack Oak; thence N. 26 1/2 W. 12.37 to a stone 3 1/2 in. thence S. 63 1/4 W. 12.34 to a pine stump 3 1/2 in.; thence N. 27 1/2 W. 43.90 to a stone 3 1/2 in. thence S. 63 3/4 W. 17.61 to a post Oak 3 1/2 in. thence S. 28 3/4 E. 58.14 to the beginning corner, Adjoining lands of Brown Estate, Howard and others, land containing one hundred and eleven and three fourths (111 3/4) acres more or less and being the same land conveyed to us by W. B. Myritt, by deed dated April 5th-1919 and recorded in the R. M. O. Office for Greenville County in Book 44 page 482. As a part of the consideration of this deed the grantee herein hereby assumes and will pay so much of the mortgage indebtedness now on the above described property as amounts to Four Thousand (\$4000.00) Dollars, together with any interest that may accrue thereon according to the terms of the note which said mortgage secures from and after January the first 1919, which is excepted from the general warranty herein after expressed.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *Lucy L. Heidman and Lelou Gillespie, their* heirs and assigns, forever.

AND *we ourselves and our* do hereby bind heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *Lucy L. Heidman and Lelou Gillespie, their* heirs and assigns, against *ourselves and our* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
