All that certain lot of land situate on the South side of East Earle Street in the First Ward of the City of Greenville, County and State aforesaid, known and designated as lot # 3 as shown on plat of property of F. N. Miller by A. E. Dalton, Engineer dated April 19, 1919, and having the following metes and bounds, to wit:
Beginning at a stake on the South side of East Earle Street one hundred and twenty feet from the intersection of Robinson and Earle Streets, joint corners of lots Nos 2 and 3, and running thence along line of lot No 4, S 60.5 E 197.4 feet to an iron pin; thence N 84.19 W 58.6 feet to an iron pin corner lot no 4; thence along line of lot No 4 N. 5.42 E 196.0 feet to an iron pin on Earle Street; thence S 85.38 E 60 feet with Earle Street to the beginning corner.
