(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said A. M. Hayes, his heirs and assigns, All of our respective undivided interests of, in, and to the two parcels of land hereinafter described, to-wit:
 All that lot of land situate in Ward Five, at the corner of Anderson and St. John Streets in the City and County of Greenville, South Carolina, having the following metes and bounds:
 Beginning at a stake at the corner of Anderson and St. John Streets and running thence Southeasterly along St. John Street two hundred (220) and twenty feet to an iron pin; thence Northeasterly along line formerly owned by B.M. McGee, about one hundred and (103) three feet to iron pin; thence Northwesterly along B.M. McGee's line about two hundred (209) and nine feet to a stake on Anderson Street; thence Southwesterly along Anderson Street one hundred (120) and twenty feet to the beginning corner.
