W. Carroll M. Daniel and Fred P. Abercrombie

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said W. Carroll M. Daniel and Fred P. Abercrombie

and their heirs and assigns, all that certain piece, parcel or lot of land situate, lying and being in South Carolina, and Greenville County, just beyond Woodside Mills, being known as Lot No. 16 on a plat of Summit View in Block "A", located on the Public Road and Goldfield Street, said plat is recorded in the R. M. L. Office for said County and State in Plat Book "A" at page 75. Said lot has a frontage on the Public Road of fifty (50) feet. For the other dimensions and widths and bounds see the above mentioned Plat. This being the same lot of land conveyed to Ella J. Sheppard by A. Schonwetter by deed bearing date February 10<sup>th</sup>, 1913, said deed being recorded in R. M. L. Office for Greenville County in Deed Book 214, page 290, and said land being subsequently conveyed by Ella J. Sheppard to S. L. Tripp by deed bearing date April 23<sup>rd</sup>, 1914. It being understood that said land here-in described is conveyed subject to a mortgage for \$200.00 (Two Hundred Dollars), executed by Alfred Dockery to S. O.
