Master in and for the County of Greenville, aforesaid, in consideration of the sum of Five Hundred (\$500.00)
Dollars,
to me paid by the said H. A. Townes

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release
unto the said H. A. Townes his heirs assigned personal

The following described real estate, to-wit: all
that certain tract of land situate, lying and be-
ing in Paris Mountain Township, Greenville County
State of South Carolina, more or less of Saluda
River bounded by lands of John McHatt Jarvis
Proci Spark P. M. Thompson and Barney the
following metes and bounds: Beginning on
a rock at the branch S.E. corner, thence down
said branch 24.25 ch. to stake at public road, thence
with McHatt's line N. 65 1/2 W. 12.50 to poplar on said
branch; thence down said branch 11.70 to
another branch; thence up and along last
named branch 26.79 to a willow X3; thence S.
53 E. 13.00 to a rock; thence S. 48 1/2 E. 12.60 to white
