 KNOW ALL MEN BY THESE PRESENTS, That *W. Warren Lipscombe*

in the State aforesaid,
 in consideration of the sum of
Five Dollars and other valuable consideration
 to *me*
 at and before the sealing of these presents by *W. T. Snow*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

W. T. Snow his heirs and assigns, situate in the State and County aforesaid and a part of lot 33 in Block D. of the Louis Villa subdivision as follows Beginning at a pin ninety three and two tenths feet from the intersection of the Buncombe Road and Brockman Avenue on the south side of Brockman Ave. and running thence S. 57.25 E. 175 feet to a stake thence N. 10.30 W. approximately 62 feet to a stake; thence N. 57.25 W. 175 feet to a stake on Brockman Avenue; thence with said Avenue S. 10.30 W. approximately 62 feet to the beginning, being the same lot conveyed to me by T. M. Taylor the 18th day of June, 1919 and recorded in Vol. 45 page 404. Also that other lot of land adjoining the above known as lot No. 32 in Block D. and described as follows: Beginning at a pin at the corner of Buncombe road and Brockman Avenue and running thence N. 10.30 E. 93 feet to a pin, being the joint corner of lot 32 and 33 on Brockman Ave. thence along the line of said lots S. 57.25 E. 175 feet to a pin; thence S. 10.30 W. 93 feet to a pin on Buncombe road, thence with it N. 57.25 W. 175 feet to the beginning, being the same lot conveyed to me by Armida D. Brunson 28 April 1919 recorded in Vol. 44, page 521.

As a part of the consideration hereof for this conveyance, the grantee does hereby assume and will pay according to their terms a note and mortgage on the lot last above described being the lot corner of Buncombe Road and Brockman Avenue for three thousand dollars to the Bank of Commerce dated April the 28th 1919 with interest that may accrue from the 15th day of August 1919.

Except however, a small triangular portion I have heretofore conveyed to S. H. Patrick, the deed therefor being recorded in Vol. 44 page 524 to which reference is here made for minute description of same.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *W. T. Snow, his* heirs and assigns, forever.

AND *I myself my* do hereby bind heirs, executors and administrators to warrant and forever defend, all and singular, the said premises unto the said *W. T. Snow, his*

heirs and assigns, against and heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
