KNOW ALL MEN BY THESE PRESENTS, That I, A.R. Robinson

in the State aforesaid,  
One thousand two hundred and Seventy five DOLLARS,  
to me in hand paid  
at and before the sealing of these presents by Hill Banks

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said Hill Banks, All that certain piece, parcel or lot of land in the City of Greenville, County and State aforesaid, on the West side of Brer Street and and having the following meter and bound: Beginning at a stake on Brer St. corner Walker Herro's lot (now owned by B. G. Geer) thence with said Herro's lot N. Sixty five feet to a stake corner Mountain City Land and Improvement Company's lot (now owned by Thomas Brer) thence with said Company's line 80 (00) one hundred feet to a stake on corner alley known as Barron street, thence with said Alley E. Sixty five feet to a stake corner Brer street, and thence with Brer Street N. one hundred feet to the beginning corner be the said dimensions more or less.

This lot was conveyed to me by deed date 23rd day of February year 1895 and recorded in volume B. B. 121 page 198 by Flora Williams, being a part of lot 42.0.4 of the Carson land, See Plat Book E page 61.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Hill Banks his heirs and assigns, forever.

AND do hereby bind

heirs, executors and administrators, to warrant and forever defend, all and singular the said premises unto the said Hill Banks his

heirs and assigns, against me my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
