DEED TO Gertrude L. Lipscombe
KNOW ALL MEN BY THESE PRESENTS, That we, Maggie Little, Sarah Little and
Alice L. Gause, Trustee, in the State aforesaid,
in consideration of the sum of
One Thousand Dollars and other valuable considerations
to us, in hand paid
at and before the sealing of these presents by Gertrude Little Lipscombe, in the
State aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said
Gertrude Little Lipscombe, One undivided one-half
interest in All that certain piece, parcel or lot
of land situate, lying and being in Ward One
of the City of Greenville, and State aforesaid, on
Washington Street being more particularly described
as follows: Beginning at a stake on North
side of said street, at the corner of lot conveyed
by Morgan and Austin to Mary A. Walden
and running thence N. 40° E. three hundred and
thirty (330) feet, to a stake on John Street;
thence with John Street N. 50° W. sixty-six (66)
feet to a stake, thence S. 40° W. three hundred thirty
(330) feet to Washington Street; thence with said
Washington Street S. 50° E. sixty-six (66) feet to the begin-
ning corner. Being the same lot of land conveyed
to J. M. Castner by Minnie M. Castner (formerly
Logan) by her deed dated May 29, 1911, recorded
in R. M. C. office for Greenville County in book
13 page 30, being the same lot of land conveyed
to Alice L. Gause and Ella Little by J. M.
Castner, by deed dated October 5, 1911, and
recorded in R. M. C. office for Greenville County
in Book 13 page 501.

so that in the will of Said Estate C. R. Little, under authority of the Probate Court
and recorded in Probate Court Book No. C-2837, was on file in the office of Clerk of Court for Greenville County.
