(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said J. P. Henderson all the following listed pieces, parcels and lots of land situated, lying and being in the town of Simpsonville County & State aforesaid: (1) That lot with metes and bounds to-wit: Beginning at a point on 100th Street, corner lot #21 and running thence along lines of lots 1421 and 221-138.21 ft. thence N. 46-15 E. 60 ft. to corner of lot #19; thence along line of said lot 136.8 ft. to said 100th Street, thence along said Cox Street 60 ft. to the beginning corner and known as lot #20 in "Hillcrest" lands. (2) That lot with metes & bounds to-wit: Beginning at a point on the corner of South & Cox streets, and running thence with South Street 72.8 ft. to corner of lot #22, thence along line of lot #22 114 ft. to lot #20, thence along line of lot #20, 69.1 ft. to Cox Street, thence along said Cox Street 135.5 ft. to the beginning corner being lot #21 in Hillcrest. (3) That lot with metes & bounds, to-wit: beginning at a point on South Street, corner of lot #21, and running thence line of lot #21, 114 ft. to line of lot #20, thence with this line 69.1 ft. thence S. 46-15 W. 92.5 ft. to a point on South Street, thence with South Street 72.8 ft. to the beginning corner being lot #22 in "Hillcrest" lands. (4) That lot with metes & bounds; Beginning at a point on Cox street, and running thence N. 46-50 W. 134 ft. to a stake thence S. 46-15 W. 60 ft. to a stake, thence S. 46-50 E. 135 ft. to Cox street, thence along said Cox Street N. 45 E. 60 ft. to the beginning corner, being lot #18 in Hillcrest lands. (5) That lot with metes & bounds; beginning at a point on Cox street, corner of lot #18 & running thence with said lot N. 46-50 W. 135 ft. to a stake, thence S. 46-15 W. 60 ft. to a stake, thence S. 46-50 E. 136.8 ft. to said Cox St. thence N. 47.5 E. 60 ft. to the beginning corner, being lot #19 in Hillcrest lands.
