H. Foster's corner and running thence with said road N. 74°-15' E. 3.17 ches. to pin, 3 1/2 N. 74, thence S. 15 3/4 E. 3.17 to pin 3 1/2 W. thence S. 74°-15' N. 3.17 to pin on Foster's line, thence with said line N. 15 3/4 W. 3.17 to beginning corner containing one acre and lying by lands of P.
