(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Jessie R. Morgan, her heirs and assigns, all that lot of land situate on the south side of Mill Avenue and having a lot no. 4 Block E, as shown on plat of Eagle Park recorded in Plat Book C, page 238. Beginning at an iron pin on the south side of Mill Avenue, folio corner of lots 4 and 5, and running thence with line of lot 5, S. 51° 42' E. 192.2 feet to an iron pin; thence S. 69° 11' E. 411 feet to an iron pin on line of the Pendleton property; thence with it N. 5° 10' W. 220.4 feet to an iron pin on Mill Avenue; thence with said Avenue S. 84° 06' 21.18.6 feet to an iron pin; thence continuing along the south side of Mill Avenue S. 88° 08' W. 44.2 feet to the beginning corner, being the same land conveyed to us by M.
