(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

L. C. Ashmore, all that certain tract of land in Grove
Township, Greenville County, State of South Carolina,
about nine miles from Greenville Court House, on the
Rock Shoals Road, beginning at a corner tree on the
west side of the Rock Shoals road and running
thence N. 85° 34' 7.65 to pine; thence S. 36° 14' 50" to pine;
thence S. 65° 46' W. 25.10 to stake, corner corner E. Ashmore's
line at Griffins Mill; thence S. 43° 06' 7.25 to stake corner of tract this day
conveyed to C. S. Brooks; thence with his line N. 63° 22' 6.2450 to stake; thence still with Brooks line S. 79° 20' E.
8.95 to pine on road to Griffins Mill; thence N. 84° 36' 10.70
to iron pin at old Rock Shoals Road; thence with said
road N. 31° E. 6.30 to pine in Rock Shoals road; thence up
said road to the beginning corner, containing 45¹²/₁₀₀
acres more or less, being all that remained of the
tract of 66¹/₂ acres, conveyed to me by L. C. Ashmore
