Davenport, all that certain piece, parcel or lot of land in the State and County aforesaid, within the City limits of Greenville on the West side of Augusta Street, Known as lot 108 of a subdivision of the Birnie Land according to a plat made by Will D. Munn, C. E. on January 9, 1911, recorded in Plat Book 6, page 200, R. M. C. Office for Greenville County and has the following lines and bounds to-wit: Beginning on the corner of lot no. 7, and running north along the line of said lot one hundred, fifty nine feet and eleven inches to McRae Street; thence along McRae Street fifty feet to corner of lot no. 9; thence along the line of lot no. 9 one hundred sixty-nine feet and nine inches to Wilkins Street; thence East along Wilkins Street, fifty feet to the beginning corner and being the same lot of land conveyed to me by J.
