This conveyance is subject to the following conditions and restrictions: The said property shall be used for residential purposes for white people only (this not to apply to servants), and no residence shall be erected on this lot to cost less than three  
\_\_\_\_\_ thousand and five hundred dollars, and the purchase hereof, his or her heirs, executors, administrators or assigns, shall be amenable to reasonable sanitary rules and regulations as set forth in Deed Colonia Company to Jos. A. McCullough, of date April 28th, 1913, and recorded in R. M. C. office, Vol. 25, page 4.

The above described land is the same conveyed to me by Colonia Company on the 22nd day of October, 1909. Deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book XXX, page 95; and on April 28th, 1913, recorded Vol. 25, page 4.
