One thousand and five hundred dollars, and the purchase hereof, his or her heirs, executors, administrators or assigns, shall be amenable to reasonable sanitary rules and regulations as set forth in Deed Colonia Company to Jos. A. McCullough, of date April 28th, 1913, and recorded in R. M. C. office, Vol. 25, page 4.

The above described land is the same conveyed to me by Colonia Company on the 2nd day of October, 1909. Deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book XXX, page 95; and on April 28th, 1913, recorded Vol. 25, page 4.
