aforesaid, have granted, bargained, sold & released
& by these presents do grant, bargain, sell & release
unto the said Jonathan Waldrop all that tract of
land containing one hundred & seventy two acres
more or less, granted unto Charlie Dean situate in
Greenville District on branches of Kilders creek,
waters of Enoree River Beginning on a black oak on
Smith Hambays line 32 thence running on said
line S. 54.50 to a stake 38 on John Hambays line,
thence on said line N. 31.50 to hickory 35, thence N.
10 E. 9 to a stake 38 on James Powells line, thence N.
46 W. 40 to a stake 38 on said Deans line thence
N. 75 E. 61 to the beginning corner together with
all and singular the rights members hereditaments
& appurtenances to the said premises belonging or
in any wise incident or appertaining

To have and to hold all and singular the premises
before mentioned unto the said Jonathan Waldrop, his
heirs & assigns forever

And I do hereby bind myself, my heirs, Executors
and administrators to warrant and forever defend
all and singular the said premises unto the said
Jonathan Waldrop, his heirs and assigns against
myself and my heirs and against every other person
whomsoever lawfully claiming or to claim the same
or any part thereof under me

the sum of ten dollars as part pay-
ment thereon, the receipt of which is
acknowledged by H. J. Eskew.
