Ellis by Simon Turner and others, heirs of Sarah Turner by deed dated August 21st, 1911, being the same tract deed to Piedmont Savings & Investment Company by J.W. 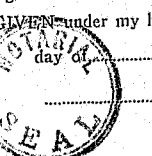
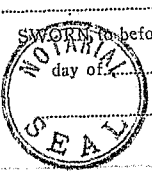
