Mayfield (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said H. M. Mayfield his heirs and assigns forever.

All of that certain piece parcel or lot of land, lying being and situated in Clinton Township, County and state aforesaid about one mile east of Simpsonville contains (5) five acres more or less and described as follows: Beginning at an iron pin in the Georgia road (stone on bank) near H. S. Hughes residence and running thence with said road N. 80 E. 3.17 to a corner in the road (stone on bank) thence N. 9 W. 14.00 to a stone on G. L. and B. L.
