WHEREAS, Mrs. Maggie Shackston

on or about the 16th day of April in the year of
our Lord nineteen hundred and twenty one exhibited her complaint in the Court
of Common Pleas, for the County aforesaid, against James G. Shackston et al

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 11th
day of April 1921, and such proceedings were had therein as resulted in a decree of the said Court, whereby it
was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman
Master in and for the County aforesaid, to P. O. Shackston

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No.)
NOW, Therefore, Know all Men by these Presents, that I, E. Inman
Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,
HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said.....

P. O. Shackston, his heirs and assigns forever, the following described
real estate, to wit: All that certain piece parcel or lot of land
situated in the town of Simpsonville, County and state aforesaid
and having the following miles and bounds, to wit: Beginning at
a point on Cox Street, and running thence with said Street N. 75
E. 60 feet to corner of lot no. 29, thence along the lines of lots
29 and 28, S. 15-15 E. 142.4 feet to stake; thence S. 75-30 W. 60 feet;
thence N. 15-15 W. 141.8 feet to the beginning corner, and being lot
no. 30, and being the same on which my dwelling house stands.

Also all that other piece parcel and lot of land situated in the
town of Simpsonville, County and state aforesaid and having the
following miles and bounds, to wit: Beginning at point on Cox
Street and running thence with said Street N. 75 E. 170.5 feet to a
stake corner of South Street, thence along South Street S. 12-25 W.
80.5 feet to corner of lot no. 28; thence along line of lot 29, S.
75-15 W. 130.8 feet; thence N. 15-15 W. 71.2 feet to the beginning corner
and being Lot no. 29.

Also all that other piece parcel and lot of land situated
in Simpsonville, County and state aforesaid and having the following
miles and bounds to wit: Beginning at a stake on South Street
and running along said Street 80 1/2 feet to a stake; thence along
a 12 foot alley 99 1/5 feet to a stake, thence along line of
lot no. 30 N. 15-15 W. 71 1/2 feet to a stake, corner lot no. 29; thence
along line of lot no. 29 N. 75-15 E. 136.8 feet to the beginning
corner and being lot no. 28.
