(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said E. B. Lewis, P. O. Lewis and R. T. Thorne, and their heirs and assigns forever, all those two certain pieces, parcels or lots of land, situate, lying and being in Greenville Township, County, land State aforesaid, just beyond the city limits of the City of Greenville, on the South side of Mills Avenue and being known and designated as Lots Nos. 9 and 11 of Block "F" the subdivision of the estate of C. C. Mills, deceased, as shown on a plat of the same which said plat is recorded in the office of the Register of Deeds for Greenville County, State aforesaid, in Plat Book "C" at page 176, said lots being more particularly described as follows to-wit:  
Lot No. 9. Beginning at a pin on the South side of Mills Avenue 123.5 feet from the corner of Church Street and Mills Avenue; thence S. 44.33 E. 180 feet to a pin on an alley; thence with said alley S. 45.27 W. 65 feet to a pin; corner of Lot No. 11; thence N. 44.33 W. 180 feet to a pin on Mills Avenue; thence N. 45.27 E. 65 feet to the beginning point.  
Lot No. 11. Beginning at a pin on Mills Avenue, corner of Church Street, thence N. 45.27 E. 58.5 feet to a pin, corner of Lot No. 9, thence S. 44.33 E. 180 feet to a pin on an alley; thence S. 45.27 W. 58.5 feet to a pin on Church Street, thence N. 44.33 W. 180 feet to the beginning point.  
The above described property being the same conveyed to the Grantor herein by her separate Deed of Conveyance bearing date February 7<sup>th</sup> 1920.  
It is mutually agreed by and between the parties to this deed of conveyance, that it is a part of the consideration hereof that the Grantees shall assume and pay when due, both the principal and interest, of two certain notes and mortgages executed by the Grantor, herein to Susan C. Mills on the above conveyed property, that is to say, one note and mortgage in the sum of Thirteen hundred dollars, covering the above described Lot No. 9, bearing date February 7<sup>th</sup> 1920, and one note and mortgage in the sum of Thirteen hundred dollars covering the above described Lot No. 11, bearing date February 7<sup>th</sup> 1920.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said
