B. Hart's lot one hundred and twenty feet to a stake on the Northwest corner of lot of land hereinafter conveyed by Eugene A. Gillilan and E. B. Houston to A. H. Cottingham, thence in a southerly direction along said A. H. Cottingham's line one hundred and eleven feet to the Southwest corner of said Cottingham's lot on line of Mrs. Elwood, thence along line of said Mrs. Elwood one hundred and twenty feet to the beginning corner, being the same lot conveyed to me by Eugene A.
