(The receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *Walter D. Boroughs*: All that certain lot of land situated in the County of Greenville and State of South Carolina and being the eastern half of the late one hundred and two in Block 17 of the Bunt lands, full lot which is recorded in Plat Book C (page 10 and more particularly described in deed from *Walter D. Boroughs* to *H. S. Powers* per *W. H. Bunt*, dated May, 1911 and recorded in Vol. 27, page 25 in 1126 copies for Greenville County; said lot being one hundred (100) feet from the northeast corner of Mt. View Avenue and Deane Street extension and runs thence with Mt. View Avenue 80-158 100 feet to an alley with said alley 7.940 feet to another alley, thence with said alley 72.30 feet to the beginning corner. Also all that other certain piece parcel or lot of land situated in the State and County aforesaid on the north side of Mountain View Avenue and being the following meter and bounds to-wit: Beginning at a stake on the north side of said Mountain View Avenue at corner of Deane Street extension and running thence with said Deane Street extension 7.940 feet to a stake at a low point alley, thence with line of said alley 8.722 feet to a stake, thence 8.920 feet to 176 feet more or less to a stake five lines of Mountain View Avenue, thence with said Mountain View Avenue 80-158 feet to the beginning corner; the same being further described as the western half of lot nos. 1 and 2 of Block 17 of Plat of Bunt lands made August 1911 and recorded in Plat Book C, Page 10, in P.M.C. office for Greenville County S.C.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *Walter D. Boroughs*, his heirs and assigns, forever.

AND *myself* do hereby bind
heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *Walter D. Boroughs*, his heirs and assigns, against
heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
