(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Annie Curry Griffin, her heirs and assigns, all that lot or strip of land situate between Broadus Ave and Mabry Street, in the City and County of Greenville, South Carolina, and described as follows: Beginning at a point 150 feet East of Broadus Avenue which Point is the South east corner of the land now owned by the grantee herein, and runs thence along her said line N. 15 1/2 W. 82 feet and pinches thence in a Northwestern direction 4 1/2 feet until it strikes a point on the line of an Alley that runs from Broadus Ave. to Mabry Street, said Point being on the point line of the lot of the grantee and said alley; thence along said alley in an easterly direction 13 feet; thence S. 15 1/2 E. 804 feet and pinches to the line of the residence lot of the grantor; thence along the line of said strip of land being cut off, and a portion of a lot of land heretofore conveyed to Virginia L. Jones by Mrs. Jemer, and has been used as a drive-way by the grantee herein from the aforesaid alley to his residence lot above referred to, and being the same strip of land conveyed to the grantor by W. P. Doyle, by deed dated the 1st day of March, 1916, recorded in V.C. 39, Page 136.
