Hottes*, all that certain piece, parcel or tract of lands, situate, lying and being in Greenville County, State of South Carolina, on the Southwestern Slope of Paris Mountain in Paris Mountain Township, and being more particularly described as follows: Beginning at a pine knot on or near road at the corner of Wallace McCullough property, and running thence S. 3-0 E. 882 feet to a stake; thence S. 27-05 E. 559 feet to stake near fork of road; thence S. 5-55 W. 444 feet to stake on road; thence S. 39-40 E. 60.5 feet to stake; thence N. 50-20 E. 230 feet to stake on or near road thence along the line of H. P. McGees property, S. 13-45 E. 1076 feet to stone; thence along line of Foster property, N. 73-15 W. 1010 feet to stone; thence S. 2-35 E. 464 feet to stone corner of tract no. 2; thence with line of tract no. 2; N. 66 W. 975 feet to a china tree, corner of tract no. 3; thence along line of tract no. 3; N. 70-30 W. 668 feet to a stone; thence N. 31-55 E. 580 feet to stone; thence N. 48-10 W. 564 feet to stone, corner of quarry tract; thence N. 32 E. 465 feet to a stone; thence N. 10-15 S. 231 feet to a stake; thence N. 32 E. 132 feet to a pine; thence N. 57-30 W. 368 feet to a chestnut oak tree; on line of Nichols property; thence N. 22-45 W. 409 feet to road; thence N. 25-40 E. 55 feet to a stone; thence S. 67-45 E. 540 feet to a stake; thence S. 43-30 E. 573 feet to stone; thence N. 64-05 E. 1073 feet to the beginning, corner being bounded on the east by lands of Foster, McGees and Mackley; on the north by McCullough lands; on the west by lands of Nichols and others; and on the south by tracts nos. 2 and 3 of the Hubbard property, and containing 115.82 acres, more or less, on plat of the property of J.
