Lee Mc Gee, all that piece, parcel or lot of land situated in Ward One of the City of Greenville County and State aforesaid, on the North side of Oak Street, part West side of Wilton Street, and hailing the following metes and bounds, to wit: Beginning at the North West corner of Park and Wilton Streets, and running thence with Wilton Street N.W. 5 $\frac{1}{2}$ feet, 200 feet to a stake; thence with the line of lands known or formerly owned by the Stone Land Company, N.E. 34 $\frac{1}{2}$ feet to a stake; thence in a line parallel with Wilton Street, S. 5 $\frac{1}{2}$ W. 200 feet or thereabouts to Oak Street; thence with Oak Street S. 24 $\frac{1}{2}$ E. 54 $\frac{1}{2}$ feet to the beginning point, and thence all of lot "F" and a part of lot "G" as shown in map No. 6 recorded in Deed Book N.B. Page 614.
