(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Rosamond Williams, her heirs and assigns, All our right title, interest and Estate of in and to all that piece, parcel and tract of land situate, lying and being in the County of Greenville, in the State of South Carolina in Bates Township, land being a part of the land conveyed to us by our father, Eddie Williams by deed dated November 28th, 1913, and recorded in R.M.C. office for Greenville County in Volume 39 page 592, the tract herein conveyed is described as follows; Beginning at a stone on line of lot number 9 and running thence N. 83 1/2 W. 26.70 to an iron pin or an old road thence with the old road in a southerly direction of 16' from iron pin in said old road; thence S. 83 1/2 E. with line of lot number 1, 23.20 to a stone; thence S. 84 1/2 E. 5.80 to a stone, the beginning corner and being lot number 8 in the division of the land conveyed to us as above set out, all of which will more fully appear by plan of the same made by W.A. Lester, Surveyor, on September 12th, 1916 and Deeds attached, containing fourteen acres.
