Chapman as Executors of the Will of William P. Chapman, by deed dated December 23, 1919, and recorded in R. M. C. Office for Greenville County in Vol. 60, page 15, and having the following metes and bounds according to survey made by W. P. Mitchell December 3, 1919: Beginning at iron 3XN in the public road; thence S. 60 1/2 W. 10.82 to iron 3XN; thence S. 43 3/4 E. 8.27 to pile of rocks 3X0; thence S. 64 1/4 W. 6.23 to wagon axle 3X0; by estate of A. M. Holliday, deceased; thence S. 24 3/4 E. 7.17 to stake 3XN, bounded by M. S.
