that certain piece, parcel or lot of land situate, lying and
being in County and State aforesaid, Greenville Township, in
Ward Two, of the City of Greenville being a portion of lot 700-44
of Section 34 of the Dixie Land Company, plat of which is
recorded in R. M. C. Office for Greenville County in Plat Book
No. 2, page 337, and having the following lines and bounds,
to wit:-

Beginning at an iron pin on the West side of Bennett
Street at the Southeast corner of lot 700-44 and running
thence N. 71° 50' W. 142 feet to an iron pin; thence S.
30° 17' 46.8 feet to an iron pin in Cleveland's line; thence
with Cleveland's line S. 54° 30' E. 148 feet more or less, to a
an iron pin on Bennett Street; thence with Bennett Street
N. 20° 19' E. 48 feet to the beginning corner. Being the same
