John Bridges, and his heirs and assigns, All of the following described real-estate
described:

First-

All that certain place, parcel or tract of land with the improvements thereon, situate,
lying this day in the State of South Carolina, and County of Greenville, on branch waters
of Rutherford Creek and of Reedy River, on Rutherford Road and having the following rates
and boundaries to-wit:

Beginning on a stone in said Rutherford Road and running thence along said Road S. 57 $\frac{1}{2}$
to 4.00 to an iron pipe; thence S. 57 E. 50.4 to a water-dak; thence S. 14 E. 15.50 to a stake;
thence N. 14 E. 15.40 to a branch; thence N. 70 $\frac{1}{2}$ E. 45 links to a stone; thence N. 24 $\frac{1}{2}$ E.
40.00 to a stone; thence S. 57 $\frac{1}{2}$ W. 2.70 to a stone; thence N. 12 $\frac{1}{2}$ E. 1.16 to the beginning
corner containing five (.5) acres, more or less. — Deed that portion heretofore sold and
conveyed theretofore to J.D. Bridges by deed dated July 7th, 1920 and recorded in R.R.C.
Office for said County and State in Vol. #52 of Deeds, at page 75 thus leaving 4.15/16
acres, more or less, unconverted in this tract.

Second.

All that other certain place, parcel or lot of land adjoining the above and being
in the State and County aforesaid in the same locality on the National Highway and having
the following rates and bounds, to-wit Beginning at a stake 43.8 feet from old Craft corner
at end of old Rutherford Road, and running thence S. 32 $\frac{1}{2}$ W. 45.3 feet to rock; thence
N. 12 $\frac{1}{2}$ E. 50.5 feet to edge of corner of National Highway; thence S. 37 $\frac{1}{2}$ E. 43 feet to
the beginning corner.

The first tract of land hereinabove described converted to me by A.D.L. Banksdale, as Agent
and Intervenor by deed dated 3rd, day of July 1920 and recorded in R.R.C. Office for said
County and State in Volume #52 of Deeds, at page 117; second tract converted to me by the
grantee herein named by deed dated 7th, day of July 1920 and recorded in the aforesaid
Office in Volume #54 of Deeds, at page 150+ to which deeds reference is hereby made.
This Deed is executed subject, however to a note and mortgage given by S.S. Griffin to
James McGee for the sum of \$100.00, bearing date 21st, day of February 1920, and recorded
in the R.R.C. Office for said County and State in Volume #52 of R.R.C. Notes, at page 159,
which note and mortgage the grantee herein named assumes and will pay as a part of the
consideration of this deed; there now being a balance due on said mortgage of \$500.00, with
interest from the date of this conveyance at the rate of eight per cent per annum, payable
annually.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said, J. D. Bridges, and his

heirs and assigns, forever.

AND — myself and my do hereby bind

heirs, executors and administrators to warrant and forever defend, all and singular, the said premises unto the said,

J. D. Bridges, and his

heirs and assigns, against

heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
