(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said A. H. Donaldson, Nannie D. Furman and Sarah C. Barnes, All that certain piece, parcel or lot of land situate lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the East side of Rutherford Street, bounded described as follows, to-wit: Beginning at a point on the East side of said Rutherford Street, a distance of one hundred and thirty-eight feet eight inches from the southeast corner of Rutherford Street and Randall Street and running thence S 83-39 E, two hundred feet to a stake; thence S 1-41 W, fifty-nine feet and four inches to a stake; thence N 83-39 W, two hundred feet to a stake on Rutherford Street; thence with Rutherford Street N 1-41 E, sixty-nine feet and four inches to the beginning corner.

Being Lot No. 9 of a plat of said Land Company, said plat recorded in the R.M.C. Office in Plat Book "A" Pages 337 & 343.

Being the same lot of land conveyed to me by Mde M. Calmes my dec'd dated June 22nd 1921, and recorded in the R.M.C. Office for Greenville County in Vol 11 Page 538.

I subject however to the mortgage heretofore executed on the 22nd day of June 1921, by me to Mde M. heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
