All that certain piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, next to the City of Greenville and being a portion of the lands of the Riverside Land Company, to-wit: the eastern part of Lot # 33 as represented on Plat of said lands as made by P. H.
