(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Alice C. Allen, All that certain piece parcel or lot of land, situate lying and lying in the County of Greenville, State of South Carolina on the west side of the Anderson Road about one-half a mile from the corporate limits of the City of Greenville and having the following lines and bounds, to-wit:

Beginning at a stake 70 on the Anderson Road and running thence N. 52 1/2 W. 12-32 to a rock 70; thence S. 35 1/2 E. 164 to a rock 40; thence S. 5 1/2 E. 11-64 to a stake 70 on the said Anderson Road; thence along said Road S. 5 1/2 E. 164 to the beginning corner less that certain piece parcel or lot of land conveyed out of the above boundaries by deed to G. C. Martin, dated March 28th, 1908 and recorded in R. M. C. office for Greenville County in Deed Book N. 11, at page 509 and described in said deed as follows:

Beginning at a stone 34' from an old bacon line and running with said line N. 50 1/4 W. 564 feet thence to a stone 34' from thence S. 36 1/4 W. 111 1/2 feet to a stone 34' from thence S. 51 1/2 E. 564 feet thence to a stone 34' from thence N. 36 1/4 E. 104 feet to the foregoing corner.

The premises herein conveyed to grantee herein, contains three-fourths of one acre more or less and is a portion of that certain land conveyed to the grantor herein by deed dated July 12th, 1904 and recorded in R. M. C. office for Greenville County in Deed Book N. 21, at page 19.
